

**June 10, 2013**

The Dale County Commission convened in regular session Monday, June 10, 2013. The following members were present: Mark Blankenship, Chairman; District One Commissioner Douglas M. Williamson; District Two Commissioner Steve McKinnon; District Three Commissioner Charles W. Gary; and District Four Commissioner James W. Strickland.

Chairman Blankenship called the meeting to order at 5:30 p. m. Commissioner McKinnon opened the Work Session with the Pledge to Allegiance. Commissioner Strickland followed with prayer.

MINUTES – MAY 28, 2013 REGULAR SESSION

BID AWARDED – RESURFACING VARIOUS COUNTY STREETS

Upon recommendation of County Engineer, Commissioner Strickland made a motion to award the bid for the resurfacing of various county streets, Project # CY-CM-PF-12-008 (CDBG), to Wiregrass Construction Company, Inc., at a bid amount of \$283,974.81. Commissioner Gary seconded the motion. All voted aye. Motion carried.
